

# Guardian Whiskers Inc (GW) and Cat Care Clinic (CCC)

## RELEASE AND WAIVER OF LIABILITY and MEDIA RELEASE FORM

PLEASE READ CAREFULLY as this document affects your legal rights.

THIS RELEASE AND WAIVER OF LIABILITY and MEDIA RELEASE FORM (the "Release") is executed by the undersigned in favor of Guardian Whiskers Inc, a Wisconsin based, non-profit corporation, and Cat Care Clinic, its directors, officers, employees, and agents (collectively, "GW and CCC").

I understand that the behavior and temperament of animals can be unpredictable and that touching, handling, or other contact with an animal may involve risk of property damage or personal injury. I also understand that if I bring a pet to the clinic, it may sustain injury or illness.

Therefore, as a condition of entering the shelter and/or interacting with animals that are in the care of the GW or CCC, I execute this Release subject to the following terms and conditions:

1. **Waiver and Release.** I hereby release and forever discharge and hold harmless GW and CCC and its successors and assigns from all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from my visit to GW or CCC or interaction with animals in the care of GW or CCC. I understand and acknowledge that this Release discharges GW or CCC from any liability or claim that I may have against GW or CCC with respect to any bodily injury, personal injury and illness, death, or property damage. I also understand that GW or CCC does not provide any insurance coverage or financial assistance in the event of injury or illness.
2. **Assumption of the Risk for Volunteers.** I understand that volunteer work/community service at the GW or CCC may include activities that could be hazardous including, but not limited to working with animals, loading and unloading equipment and materials, and transportation relative to work being performed. Anyone wishing to volunteer for Guardian Whiskers or Cat Care Clinic must complete a volunteer orientation.
3. **Photographs and Media.** I grant Guardian Whiskers, Inc., and Cat Care Clinic, its representatives, employees, as well as news and print media outlets, permission to use photographs of me with or without my name and for any lawful purpose, including for example, such purposes as publicity, illustration, advertising, web content, and social media.
